BURNING ISSUE

ICPD + 20 Process in European region ended with a strong reaffirmation of Cairo principles

The Regional [UNECE](#) Conference: **Enabling Choices: Population Priorities for the 21st Century** on 1-2 July in Geneva, Switzerland concluded after a two day review of the achievements and remaining challenges of the ICPD Programme of Action Europe, Central Asia and North America. Discussions were oriented around the [UNECE Regional Report](#) which is based on the results from the Global Survey. The Conference was organized under three themes of Population Dynamics and Sustainable Development; Families, Sexual and Reproductive Health over the life course and Inequalities and Social Inclusion and Rights.

Over 40 civil society participants attended the conference and they also had an opportunity to apply for an intervention (for a full list of interventions click [here](#)). ASTRA Network Coordinator made an [intervention](#) on behalf of the Federation for Women and Family Planning, Polish member of ASTRA

serving as its Secretariat, on the discussion topic on “Families, Sexual and Reproductive Health over the life course”. She stated strongly that the current developments in Central and Eastern Europe are not in alignment with the ICPD PoA and several countries have made attempts, some even successful, to restrict access to safe and legal abortion.

The outcome document reflects the core issues of ICPD PoA but also underlines that the region has significantly changed over the past 20 years. It includes recognition that “policies in both low and high fertility countries should be based on the right of individuals to decide freely and responsibly on the number and spacing of their children and to have the information and means to do so”. Low fertility and aging of the society is not considered to be a threat but a possibility and small populations can live prosperous, long and healthy lives. There was a strong support for human rights approach to sexual and reproductive health and participants called for “removal of all barriers preventing women and girls from access to safe abortion” as well as enable access to comprehensive sexuality education and youth friendly services. HIV and STI treatment and prevention should be part of health systems and, especially in Eastern Europe, needs more attention and funding. The outcome document also recognized criminalization of sex work as a public threat.

“There are three main messages coming out of the conference: the ICPD agenda is unfinished business in the region, there are new population dynamics that need to be addressed, and the principles developed in Cairo two decades ago remain highly relevant to tackle these challenges” said Werner Haug, UNFPA Regional Director for Eastern Europe and Central Asia.

Civil Society meeting after the UNECE Regional Conference

On 3-4 July ASTRA had the pleasure to co-host a Civil Society meeting “**ICPD Beyond 2014 – From Promise to Action, CSOs Defining the Way Forward**” which was organized by IPPF European Network in Geneva following the UNECE Regional Conference. European Women’s Lobby, a regional network, was the other co-host of this meeting. This collaboration across the region reinforced the ICPD Beyond 2014 process and the engagement of civil society within it. It was also an opportunity to provide space for dialogue and action for the CSO on how to advance the ICPD PoA and related issues in the region following the Review, and define strategies to address these challenges and priorities in the upcoming global discussions, such as the ICPD Beyond 2014 and post-2015 negotiations. The meeting gathered 70 participants from civil society organizations working in various themes such as Human Rights, HIV/AIDS, Sex work, youth organizations, SRHR amongst others from both national and regional level to broaden the level of support and strengthen advocacy power within the region. The meeting was organized around plenary sessions and working group sessions. Several ASTRA members were present at this meeting and brought their expertise and experience into the discussions and ensured that the unique reality of Central and Eastern Europe remains visible within the European region and within the ICPD+20 process.

REGIONAL UPDATES

Draft bill banning abortion in case of fetal malformation is back in the Polish Parliament

Civic bill proposing to ban abortion in case of fetal malformation has made its way back to the Polish Parliament. The civic bill collected over 400 000 signatures of support. The Parliament will now have 90 days to work on the draft legislative bill proposed by the "Stop Abortion" civic initiative. The future developments are difficult to assess as two years ago the draft bill banning abortion totally was not rejected in the first reading but in the second and with slight difference in voting. The restrictive legislature has many supporters in the conservative wing of the ruling party, the Civic Platform. The current law allows abortion in three cases only; in case of rape/incest, in case of a threat to the woman's health and in cases of fetal malformation. According to official numbers from the Ministry of Health there were 669 abortion and none resulting from or any other crime in year 2011. This figure, in a country of over 38 million inhabitants, illustrates how difficult it is to access a legal abortion in practice. The Polish Government constantly ignores the harmful effects of current legislation. According to results of a study conducted by a Polish public opinion research institute, at least one-quarter, possibly up to one-third of women in Poland, have had an abortion at least once. This adds up to 4,1 million to 5,8 million women who undergo illegal abortions or travel abroad.

PACE condemns the new law on abortion in Macedonia

On 27 June, 20 Members of the Parliamentary Assembly of the Council of Europe tabled a Written Declaration "The new Abortion Law of the former Yugoslav Republic of Macedonia violates international standards" where they expressed grave concern about this recent legislative development. They criticized the urgency of the procedure as well as failure of the law to correspond to any international or European standards. Finally Members urged Macedonian authorities to "ensure that international standards based on sound science, medicine and human rights serve as primary guidance in this area of legislation".

EP DEVE Committee in favor of SRHR in development policy

Early in July Members of the European Parliament's Development Committee were called to vote on an opinion on the Sexual and Reproductive Health and Rights for the [Committee on Women's Rights and Gender Equality \(FEMM\)](#). The vote passed with a three-quarter majority. The opinion was authored by a British Member of the European Parliament Michael Cashman who stated that "Today's vote is an affirmation of where the parliament stands and its support for a really progressive set of policies". The opinion insists on the fact that universal access to sexual and reproductive health and rights is a fundamental human right, urges the European Commission to maintain SRHR in the development priorities of the EU and calls for a specific line on SRHR under the Development Cooperation Instrument thematic lines, as well as sufficient funding for the broad SRHR agenda in all appropriate instruments. Moreover it urges the EU to ensure that population dynamics and inclusive and sustainable development linkages, and SRHR are a priority in shaping the post-2015 global development framework and calls on the Member States to ensure the integration of the ICPD+20, Beijing+20 and Rio+20 processes within the post-2015 framework. It also calls on the EU and its Member States to keep their commitments to the full and effective implementation of the ICPD PoA and the outcomes of their review conferences. This opinion will be voted in the FEMM committee on 18th September and in the plenary in October together with the draft report, which covers contraception, unwanted pregnancies and abortion, sexuality education, violence, maternal mortality, prevention and treatment of sexually transmitted infections and official development assistance.

GLOBAL UPDATES

ICPD Conference on Human Rights

[The ICPD International Conference on Human Rights](#) took place in Noordwijk in the Netherlands on July 7-10 and gathered a group of 300 representatives of government, parliaments and civil society groups from 130 countries. This three day conference was designed to identify achievements, barriers and best practices in relation to achieving the goals of the ICPD Programme of Action. Hosted by the Government of the Netherlands and delivered in partnership with the United Nations Population Fund, and the Office of the United Nations High Commissioner for Human Rights, the event was the second thematic conference after the [Bali Global Youth Forum](#) held in December last year. Conference sessions were structured around themes including women's autonomy and reproductive rights, sexual health and well-being and human rights and gender-based discrimination and violence. Among the key speakers one could find Nafis Sadik, Special Adviser to the UN Secretary General and His Special Envoy for HIV/Aids in Asia, who boldly underlined in her speech that the ICPD PoA consensus does not address the rights of the woman who needs an abortion where it is not legal and that "illegal abortion is unsafe almost by definition".

In the closing session Chair of the conference, Marijke Wijnroks shared reflections, key messages and recommendations that emerged from various discussion throughout the event. She highlighted gains that had been made in reducing maternal mortality; increasing girls' access to education; improving access to contraception; and the introduction of laws to outlaw child marriage and expand access to safe abortion. Achieving gender equality, elimination of violence against women including sexual violence, empowerment of women, girls and marginalized groups along with the engagement of men and boys to fight for equality and end violence, were highlighted as key issues that had been woven through discussions. Strong message came from the delegates who claimed that rights related to sexuality and reproduction are universal human rights regardless of race, sex, ethnicity, religion, political, other opinion, or any other status. Access to information, education and participation free from violence was emphasized as foundational to the exercise of rights and the role of NGOs, human rights defenders and service providers in supporting this access was picked up as requiring protection and support. The Chair stated that culture, religion or tradition could not be used as a justification for human rights violations. Serious barriers in access to comprehensive sexuality education and to sexual and reproductive health services, in particular adolescents, were highlighted and "grave

concerns were voiced about discrimination, violence and human rights violations against LGBTQI individuals. Calls were raised to treat all human beings with respect”.

One of the identified facilitators in progress towards the goals of ICPD and the achievement of universal human rights was accountability. The role of existing international agreements, court judgements and human rights frameworks and the potential of partnership with Parliamentarians were also identified as important facilitators in changing policy.

The final outcome document of the conference is yet to come. Findings of the discussions will inform the UN Secretary-General’s report to the 47th Commission on Population and Development in April 2014 and the General Assembly special session later that year.

Montevideo Consensus Urges Countries to Change Abortion Laws

The Regional Population Conference took place in the Latin America and Caribbean region within the ICPD Beyond 2014 Review Process on August 12-15 and ended with a strong affirmation for Sexual and Reproductive Health and Rights. The [Montevideo Consensus on Population and Development](#) calls on “states to consider amending their laws, regulations, strategies and public policies relating to the voluntary termination of pregnancy in order to protect the lives and health of women and adolescent girls, to improve their quality of life and to reduce the number of abortions”. It also recognizes that reproductive rights and sexual rights are separate concepts and thus enables the ICPD Programme of Action agenda to move beyond its initial frames. Moreover it underlines that “a secular state is one of the elements fundamental to the full exercise of human rights”.

UNECE Youth Call to Action was developed at the Regional Youth Forum for UNECE region in Istanbul, which took place in Istanbul, on May 30-31st 2013. The document reaffirms and builds upon the Bali Declaration and identifies the new and emerging issues that young people from the UNECE region face in relation to advancing the ICPD Programme of Action. UNECE Youth Call to Action calls

for the full integration of a rights-based approach to the ICPD Beyond 2014 and Post-2015 Development Agendas. Full text is available [here](#).

The document was presented at the **UNECE Regional Conference** “Enabling Choices: Population Priorities for the 21st Century” held in Geneva, on July 1-2nd 2013, in which there were 15 youth delegates chosen from participants of the Regional Youth Forum for UNECE region held earlier in Istanbul. ASTRA Youth representatives were selected and represented the voice of the region’s young people, ASTRA Youth had also the possibility to have an [intervention](#) in the session on Inequalities and Social Inclusion and Rights. The youth delegation was given dedicated time in order to present the outcomes of the Regional Youth Forum, along with the input gathered from the online platform and the national consultations.
