# **BURNING ISSUE**

Central and Eastern Europe Health Consultation. 20 advocates participated in health consultation convened by ASTRA and Eastern European Alliance for Reproductive Choice (EEARC). ASTRA Network in partnership with EEARC was selected by the World Health Organization to take forward a Central and Eastern Europe Health Consultation in the post-2015, as a part of a global consultation process: The World We Want. The meeting took place from 26<sup>th</sup> to 27<sup>th</sup> January 2013 in Moscow, Russian Federation. 20 experts from from Armenia, Azerbaijan, Lithuania, Moldova, Macedonia, Romania, Ukraine, Uzbekistan, Kyrgyzstan, Kazakhstan, Tajikistan, Russian Federation, Bulgaria, Romania, and Poland prepared recommendations that will contribute to shaping post-2015 development framework in order to improve health status in the region, especially in terms of sexual and reproductive health. Participants discussed and developed a shared understanding on the positioning of health in the post 2015 development framework; proposed health goals and related targets and indicators for the post-2015 development agenda, as well as approaches for implementation, measurement and monitoring that reflect specific regional situation regarding uneven progress towards universal access to health in order to ensure that the post-2015 framework will be empowering for women by providing them with access to health. The recommendations from the meeting fed into the Global G8/G20 Civil Society Working Group consultation and were sent to WHO. WHO will use regional recommendations to prepare the final report for the High Level Panel.

# **REGIONAL UPDATES**

Public hearing on sexual and reproductive health and rights in the European Parliament. The European Parliament Women's Rights and Gender Equality Committee organized a public hearing on sexual and reproductive health and rights on January 22<sup>nd</sup>. The aim was to discuss SRHR as a gender equality issue within and outside the European Union. Thilde Knudsen, Marie Stopes International Head of Europe office, highlighted the importance of investing in SRHR in low- and middle-income countries for the future inclusive and sustainable development of individuals, families and communities. Sietske Steneker, Director, UNFPA Brussels Office, called on the European Parliament to contribute to make SRHR as defined by the International Conference on Population and Development, a reality both within and outside Europe. Krystyna Kacpura, Executive Director of Polish Federation for Women and Family Planning represented ASTRA Network and discussed the access to Sexual and Reproductive Health and Rights services and supplies in the Eastern European countries of the European Union. She called for reducing inequalities between citizens of new and old member states by the concentrated effort of the EU to address reproductive health and right issues in CEE countries. Other renowned experts presented their views in discussion panels, such as health literacy and sexuality education, public health systems and accessibility in the EU and the role of the EU in promoting these rights globally.

**Abortion restrictions in Belarus.** Several changes to the law on abortion have been introduced. The number of social grounds which allowed abortion was reduced from ten to two. Abortion on social grounds is now available up to the 22<sup>nd</sup> week for victims of rape and women who were deprived of maternal rights. Abortion on request continues to be available up to 12th week. Abortion based on medical indications is currently still available without restrictions.

**Sex-selective abortions in Albania.** Albania, like most countries of the Central and Eastern Europe, has a liberal law on abortion. Under the current one abortions are legal during the first trimester. The status of women is however very low what can be observed in the son-preference phenomenon and the numerous cases of sex-selective abortions in the country. Even though this finding has caused public debates the health authorities deny evidence of this issue. Nonetheless the Minister of Health has ordered a task force to review the enforcement of the abortion law.

Romanian Mediation Law includes cases of rape. The project for the new Mediation Law in Romania requires victims of rape to go through a mandatory meeting with a mediator that would present to them "the advantages of mediation" in dealing with their rape case. The mediator would also

encourage victims of rape to use mediation, before their complaint is accepted by the court.

The only clinic in Hungary offering pharmaceutical abortion closed. Due to political pressure the private clinic, located in Budapest, decided to close down. This forces a big number of women to travel abroad to access pharmaceutical abortion, mostly to Austria. The law on abortion continues unchanged however medical abortion is unavailable.

Three bills on civil partnerships rejected in the Polish Parliament. All three draft bills concerning civil partnerships would give some legal protection not only to heterosexual couples but also to gay and lesbian. The bills were proposed by the ruling Civic Platform, the Palikot's Movement and the Democratic Left Alliance. The motion to reject these bills was supported by an alliance of two conservative parties, Law and Justice and Solidarity Poland. They also used this opportunity to attract media attention with statements referring to the Polish constitution being obliged to protect the institution of marriage as a relationship between man and woman. In spite of this MPs intend to resubmit draft laws on civil partnerships already this year.

Russian Duma approved law on banning "propaganda of homosexuality". This federal law was approved at its first reading at the lower house of Parliament on January 25<sup>th</sup>. The civil society, especially the LGBT activists, engaged in protests and expressed their concerns about this law. "We are extremely concerned that the Russian Duma has passed this discriminatory bill in its first reading. The experience of similar regional laws has already shown that they are used to curtail freedom of expression and assembly. They have also lead to an increase of threats and harassment towards the LGBT community. We therefore strongly urge the Russian Duma to dismiss the bill" said Cecilia Rosing, Program Officer for Eastern Europe and Central Asia at Civil Rights Defenders. The bill will be further discussed within the Committee on Family, Women's and Children's matters which will prepare it for a second reading and adapt the language to the Russian legislation. If the bill passes the second and third reading and receives the President's signature it will clearly curtail the right to freedom of all LGBT people in the Russian Federation.

Landmark Strasbourg ruling on same-sex couples. The European Court of Human Rights stated that religious beliefs may not interfere with the rights of same-sex couples. The Court examined four cases which were all brought by Christians; two of them claimed their right to refuse a service to same-sex couples on the basis of their religious beliefs. Sophie in't Veld, Vice-President of the European Parliament's LGBT Intergroup commented on this outcome: "With this ruling, the court has established that freedom of religion is an individual right. It is emphatically not a collective right to discriminate against LGBT people, women, or people of another faith or life stance."

The EU Irish Presidency will support gender equality at EU and international level. Minister of State responsible for Disability, Older People, Equality & Mental Health, Kathryn Lynch, presented to the European Parliament committee on Women' rights and Gender Equality (FEMM) the priorities of Ireland during its EU presidency which will last from January to June 2013. Violence against women will be a priority topic under this Presidency as Ireland will closely follow the Commission of the Status of Women on violence against women. In March they will lead the EU delegations and ensure a strong UN position on this topic. During the debate with the Members of the European Parliament of the FEMM Committee, MEP Parvanova (ALDE, Bulgaria) and MEP Romeva i Rueda (Green, Spain) called on the Irish EU Presidency to put violence against women as one of the priorities of the external actions of the EU. In addition, MEP Bozkurt (S&D, the Netherlands) also stressed the critical issue of Female Genital Mutilations.

Third High Level Panel (HLP) meeting on the Post 2015 Development took place in Monrovia, Liberia, from 28<sup>th</sup> to 30<sup>th</sup> January. Consultations with CSOs were organized by the Africa-wide post-2015 Working Group and the Liberian CSO post-2015 Working Group; working in partnership with Beyond 2015, the UN HLP Secretariat Outreach desk, the UN SG Secretariat, and representatives from other southern CSO networks. Sustainable Development Goals to replace the Millennium Development Goals. The UN General Assembly has adopted by consensus the draft decision on the Open Working Group on Sustainable Development Goals (SDGs). The first meeting of the group is expected to take place in early February. The draft decision (A/67/L.48, Rev 1) was agreed on 9 January 2013, and announced by the Permanent Representative of Brazil to the UN, who chaired the consultations. The SDGs seek to guide countries in achieving targeted outcomes within a specific time period, such as on universal access to sustainable energy and clean water for all, and will build on the anti-poverty targets known as the Millennium Development Goals (MDGs) after their 2015 deadline.
