BURNING ISSUE

The ICPD Beyond 2014 Global Report

The ICPD Beyond 2014 Global Report is the culmination of the two year long UN review of progress, gaps, challenges and emerging issues in relation to the ICPD Programme of Action agreed in Cairo 20 years ago. The ICPD+20 Review Process encompasses input from member states (through the Global Survey), outcomes of and information gathered at the Thematic Conferences (Global Youth Forum, International Conference on Human Rights, Expert Meeting on Women's Health) and Regional Population Conferences. The report gathers data from 176 member states, alongside inputs from civil society and comprehensive academic research. It provides vital support for member states continued commitment to ICPD and asserts the programme's relevance to the Post-2015 development agenda.

At the core of the Global Report, are inequalities – the cost of inequality for dignity and for sustainable development, and how investments in gender equality and rights, in youth, health and

education and securing the human rights of all are essential to deliver sustainable global development goals.

The ICPD report promotes a human-rights based approach to health. It affirms the fundamental rights to life and to security of the person, as well as freedom from cruel, inhumane treatment and from discrimination. It discusses sexual and reproductive health and rights to a broad extent and urges member states to remove unnecessary restrictions on abortion as "the more restrictive legislation on abortion is, the more likely abortion is to be unsafe and to result in death". It also recalls that the vast majority of governments allow abortion on request, or to save the life of the woman, or for at least one other condition such as fetal anomaly. Moreover the report stresses the importance of comprehensive sex education and access to contraception as key factors decreasing the need for abortion and embraces women's empowerement and gender equality.

ASTRA at the 8th session of the UN Open Working Group on Sustainable Development Goals

ASTRA representative attended the 8th OWG session in New York which was held on February 3-7 with the main theme on "Promoting equality, including social equity, gender equality and women's empowerment". This was also the last thematic session of the OWG before it moves into the phase of intergovernmental negotiations in early March.

Government report from implementing Anti-Abortion Act in 2012 in Poland

Polish government published - with a big delay - its 2012 report from the implementation of the so-called Anti-Abortion Bill. The law obliges the government to inform the society about the impact of strict regulations but - as in previous years - the document makes no attempt to assess the influence of the provisions on women's health and lives. According to the report the number of legal abortions rose compared to 2011 and amounted to 757. The Federation is preparing its analysis of the report and the document is waiting for debate in parliamentary committees and final vote in plenary.

Abortion debate reopened in Romania

Florica Chereches, member of the Romanian Parlament and member of the liberal party PNL, reopened the debate on mandatory counseling sessions for women requesting abortion on demand and declared to campaign in the next years for amending the current abortion law. According to Mrs Chereches, women seeking abortion should be required by law to take between 5-7 days mandatory reflection/waiting period so as to ensure that women with unwanted pregnancies are presented with options and allegedly would then make the "correct" informed decisions. In her statement Mrs Chereches declared that her motivatation for her planned campaign lies in the fact that Romania has a high abortion rate, especially among adolescents. She is convinced that tougher laws and regulations on abortion will make women reconsider their decisions but will also cause cuts in medical costs associated with abortion and post-abortion care.

Visit of UNFPA Executive Director to Georgia

Dr Babatunde Osotimehin, Executive Director of UNFPA, the United Nations Population Fund, and Under-Secretary General of the United Nations, visited Georgia on February 16-18, 2014 to participate in UNFPA's Planning Meeting for the Eastern Europe and Central Asia region. During his official visit, Dr. Babatunde Osotimehin met the Prime Minister of Georgia, Mr. Irakli Garibashvili and the President of Georgia, Mr. Giorgi Margvelashvili, as well as the top officials of the partner ministries to discuss cooperation and reiterate UNFPA's support to the Government of Georgia for implementing the ICPD Programme of Action.

The visit of the Executive Director was a significant event for UNFPA's Georgia Country Office, as it celebrates 15 years of presence in Georgia in 2014. UNFPA's support to the country within the framework of the second Country Programme (2011-2015) aims to support the fulfillment of the country's international commitments, such as promotion of reproductive health and rights of the population, strengthening gender equality and combating gender-based violence, empowering youth and strengthening national capacities for generating reliable population data for informed policy-making and planning where CSO involvement is crucial.

One of the milestones of development is CSOs meaningful involvement in shaping national , regional and international agenda of SRHR and building linkages between ICPD beyond 2014 and post-2015 development agenda. "Building strong networking that dials with the empowering CSOs and bringing up the voice of the most marginalized is crucial in terms of planning and implementing targeted interventions under development framework. ASTRA Network has been strongly contributing advocating for SRHR already a while within the CEE region as well as effectively cooperating with us on national level. We do appreciate the commitment and count on further coordination" - claims Ms Natalia Zakareishvili (MD, MPH) Programme Analyst of UNFPA Georgia.

MEPs back plan to end violence against women

On Tuesday February 25th MEPs backed calls for the EU to come up with a plan to end violence against women throughout the bloc and supported the Antonia Parvanova "Combating Violence against Women" report. MEP Parvanova requests the Commission to present an EU-wide Strategy and an Action Plan to combat violence against women. It also calls on the Commission to promote national ratifications and launch the procedure for the accession of the EU to the Istanbul Convention on violence against women. It urges the Commission to establish an EU Year to End Violence against Women. Finally, the report asks the Council to activate the passerelle clause, by adopting a unanimous decision identifying gender based violence (including FGM) as an area of crime listed in Article 83(1) of the Treaty on the Functioning of the European Union.

Between 20-25% of women in the EU are said to have suffered physical violence at least once in their lives. Around 3,000 die every year.

European Parlament for criminalisation of buying sex

On Wednesday February 26th members of the European Parlament backed a report proposed by the London MEP and Labour spokeswoman for women in Europe, Mary Honeyball: Report on sexual exploitation and prostituion and its impast on gender equality. It recommends the adoption of the Nordic model of sex work that legalises selling sex but criminalises buying it and points out to this model as a successful approach to prevent trafficking, support and assist female sex workers, and change mentalities in terms of gender equality. This non-binding resolution stresses that sex work violates human dignity and human rights, whether it is forced or voluntary, and calls on member states to find exit strategies and alternative sources of income for women who want to leave sex work. The Honeyball report was adopted by 343 votes to 139, with 105 abstentions

Empowering people and women defended as a priority in the post-2015 development agenda

On February 13-14 the European Economic and Social Committee (EESC) organised a conference on the Post-2015 framework. The event, entitled "A new global partnership: European civil society positions on the post-2015 framework", gathered representatives from all spectrums of civil society, who were invited to react to the conclusions put together by different EESC working groups.

The panel debates included Mr. Csaba Kőrösi, Permanent Representative of Hungary to the United Nations and Co-Chair of the UN Open Working Group (OWG) on Sustainable Development Goals who specifically addressed sexual and reproductive health and rights and stated that the co-Chair's

Sumary on the OWG session would include a balance between progressive and more conservative views on the issue. Mr. Kőrösi also confirmed that gender is expected to be strongly integrated in the SDGs. Throughout the debate, representatives stressed that the new framework needs to be transformative and have an integrated and multi-level approach. The debate also highlighted the need for a human-based rights approach to be undertaken at all levels. Several speakers and members of the audiencje defended the position that SRHR, women's empowerment and gender equality must be at the heart of the new agenda.

European Parliament called for EU LGBT Roadmap

On February 4 the European Parliament adopted a report calling on the European Commission to adopt an EU Roadmap tackling homophobia, transphobia and discrimination on the grounds of sexual orientation and gender identity (*Lunacek Report*). According to this report the EU law should protect all citizens against discrimination, including when they are lesbian, gay, bisexual or transgender as living free from threats and discrimination isn't a 'personal interest', but a human right. GLOBAL UPDATES

UN Open Working Group ends the "stock-taking phase" and releases its summary report and dokument on focus areas

The Co-Chairs of the Open Working Group (OWG) of the General Assembly on Sustainable Development Goals have completed their summary report (access it here) on the work of the Group during its 'stock-taking phase'. This document will serve as a basis for its work going forward as from 3 March the intergovernmental negotiations on SDGs will begin.

In the report, Csaba Kőrösi, Permanent Representative of Hungary, and Macharia Kamau, Permanent Representative of Kenya, summarize the Group's first eight sessions, held between March 2013 and February 2014. The draft document includes summary points from the 18 agenda items (among them: Health, population dynamics; Human rights, the right to development, global governance; Promoting equality, including social equity, gender equality and women's empowerment) discussed by the Group, and also recalls the daily meetings held with Major Groups and stakeholders, an intersessional meeting focused on rights-based SDGs, an Expert Group Meeting on Science and Technology for SDGs and an informal meeting on measuring progress with members of the statistical community. Moreover, the OWG has come forward with a document on focus areas (access it here) which has already been shared with UN Member States. The Group must report to the UNGA during the 68th Session (by September 2014).

Opportunity for civil society to make their views known on the focus areas document by the OWG.

A page has been created on the World We Want 2015 website for civil society to make their thoughts heard on the focus areas. All civil society representatives are encouraged to submit their comments

answering the following questions:

1. Regarding the 'focus areas document' overall: What do you agree with and what is missing?

2. Per specific focus area, what do you agree with and how would you improve it?

This open consultation will run from Monday 24 February to Friday 14 March 2014. It is a chance to make CSO voices heard in advance of the next OWG session starting 3 March where UN member

states will move into a process of identifying SDGs and accompanying targets.
