
BURNING ISSUE

UNFPA Regional Conference: Promoting Health and Rights, Reducing Inequalities

UNFPA, in partnership with the Government of Bulgaria hosted The Regional Conference 'Promoting Health and Rights, Reducing Inequalities: Towards Better Sexual and Reproductive Health Outcomes in Eastern Europe and Central Asia. It took place on 27-29 May 2015 in Sofia, Bulgaria. This platform for dialogue among ministers of health, parliamentarians, national and international experts, CSO representatives, regional partners and UN agencies elaborated on how to advance sexual and reproductive health (SRH) and reproductive rights in Eastern Europe and Central Asia. The content was built on the recommendations that emerged from the ICPD Beyond 2014 Regional Review Conference, held in Geneva in July 2013, and on the discussions related to the Post-2015 Development Agenda.

"A person-centered approach to the world's development agenda is simply essential," said Kate Gilmore, UNFPA's Deputy Executive Director at the opening session. "Without putting people at the center - enabled and supported through the realization of their rights to, for example, health and education - they will not realize their full potential. Without their fuller potential realized, their capacities to be productive, engaged and constructive contributors to the sustainability and resilience of their communities and economies is undermined."

The conference ended with an agreed outocome document – the Sofia Declaration of Commitment

Council of the European Union recommits to SRHR on conclusions on gender in development

On May 26th, the Council of the European Union adopted conclusions on Gender in Development. This text precedes the adoption of the new EU Plan of Action on Gender Equality and Women's Empowerment 2016-2020 (GAP II), expected during the second semester of 2015. In this text, the Council 'remains committed to the promotion, protection and fulfilment of all human rights and to the full and effective implementation of the Beijing Platform for Action and the Programme of Action of the ICPD and the outcomes of their review conferences and remains committed to sexual and reproductive health and rights (SRHR), in this context'. That same paragraph further reads that 'Having that in mind, the Council reaffirms the EU's commitment to the promotion, protection and fulfilment of the right of every individual to have full

control over, and decide freely and responsibly on matters related to their sexuality and sexual and reproductive health, free from discrimination, coercion and violence. The Council further stresses the need for universal access to quality and affordable comprehensive sexual and reproductive health information, education, including comprehensive sexuality education, and health-care services.' Throughout the text, the Council stresses the importance of promoting a holistic and inclusive approach 'to promote women's and girls' rights, gender equality and the empowerment of women and girls in all spheres of society and throughout their life cycle', namely by involving civil society organisations and by addressing several sectors, such as health and education.

European institutions adopt a strong position for a global partnership for development favourable of gender equality and health

On May 19th, the European Parliament (EP) adopted in plenary its resolution on Financing for Development. In this text, the EP states that 'gender equality, social cohesion and the fight against inequalities should remain at the core of development activities'. For this purpose, the EP calls for the implementation of gender budgeting, for targeted investments in key sectors such as health, and for a gender equality measure that should complement GDP in order to measure new social and environmental challenges. Moreover, in this resolution the EP 'stresses the decisive importance of good governance, human rights protection [...]; especially supports investment in capacity-building, basic social services such as education and health (ensuring universal health coverage), including sexual and reproductive health and rights, [...] and the fight against poverty and inequality, including among children and in terms of gender'. On May 26th, the Council of the European Union also adopted conclusions on the 'New Global Partnership for Poverty Eradication and Sustainable Development after 2015'. In its position, the Council reiterated the need to ensure access to health as a basic service that enables human capital. In addition, the text reads that 'Gender equality and women's empowerment, as well as being ends in themselves, are a key means of implementation and should be promoted at all levels', and such importance can be read through in different sections, including the chapter dedicated to 'enabling environment'. These texts are a key step towards the finalisation of a common EU position for negotiations ahead of the Third International Conference on Financing for Development, taking place in Addis Ababa next July.

All-Ukrainian Family Planning Week

On May 11th to 17th the Family Planning and Reproductive Health Prevention Week tok place in Ukraine. Within this period of time number of events and activities were conducted in all regions of the country. Even though the majority of events were aimed to raise awareness of Ukrainians on FP and RH issues, some activities were also aimed to advocate sexual and reproductive rights of different target groups, including people with mental disabilities, HIV-positive people etc. Among the activities one could choose from thematic competitions, photo exhibitions, lectures, trainings, workshops and debates, street actions, quests and flash mobs for youth, social theatre performances, exhibitions of thematic literature and medical consultations provision, round tables and press conferences. All participants of these activities received a number of information materials consisted information on sexual and reproductive rights, contraception, FP services, thematic web sites and hot line on RH etc., provided both by WHFP and partner NGOs and projects. Due to this a significant number of different target groups' representatives were reached with reliable SRHR information.

This wave of events was initiated by Women Health and Family Planning Charitable Foundation and mostly conducted by NGOs – members of All-Ukrainian Coalition of Reproductive Health and Family Planning, which was created in 2014 under the initiative of WHFP. The plan to support All-Ukrainian Family Planning and Reproductive Health Prevention Week was previously included into the Coalition' Strategic and Operational Plans as well as in its Communication strategy. One of the main Coalition' tasks is the advocacy of continuation of the current State Reproductive Health Program till 2015 in order the progress achieved in RH sphere was not lost, but due to state support was going on, in particular in order to reach the MDG.

Women's Rights Center raising awareness activities on domestic violence

Women's Rights Center in Armenia organized informative meetings on domestic violence, as part of WRC regular raising awareness activities in May. The meetings were conducted with two diverse groups: students of the Faculty of Philosophy of Yerevan State University and parents of Basic School in Yerevan. The discussions with parents and students started with presentation of WRC, its goals and activities enhancing Sexual and Reproductive Health and Rights and then there was a screening of social films on domestic violence. After the films the lively debate took place. Participants discussed the films, problem of domestic violence, ways of preventing and combating it, as well as negative psychological impact of violence on women and. At the end of the meeting the participants expressed their feelings and attitudes towards the issue of violence. Additionally, parents who took part in the meeting raised questions and appreciated WRC's significance. The organization's representatives responded to all questions and highlighted the importance of raising awareness on domestic violence among Armenian population. Such kind of events are regarded by WRC as crucial to help people gain information and empower gender equality attitudes. They also increase the awareness of girls about their right to be free and protected from domestic violence.

Project enhancing LGBTI people's rights in Georgia and Armenia

Homophobia is still not a recognized social problem in Armenia. LGBTI persons represent one of the most discriminated against, marginalized and least visible groups and face extreme violence and oppression from the public. To enhance protection of and respect for LGBTI people's rights and to combat homophobia and support LGBTI people's inclusion in Georgia's and Armenia's respective societies, the South Caucasus Regional Office of the Heinrich Boell Foundation (HBF) initiated the "Solidarity Network for LGBTI in Armenia and Georgia" project designed by a working group composed of Georgian and Armenian partner organizations: Women's Initiatives Supporting Group (WISG) and Human Rights Education and Monitoring Centre (EMC) from Georgia; Society Without Violence (SWV) and PINK Armenia from Armenia.

The specific objectives of the project are to support LGBTI people in the full scale realization of their rights through the enhancement of an LGBTI friendly environment and to stimulate civil society actors' higher cohesion on sexual orientation and gender identity issues (SOGI) in Georgia and Armenia. In the framework of this project, SWV is mainly responsible for managing components of journalists capacity building, micro grants, capacity building of CSOs in Armenia as well as for the implementation and preparation of baseline assessment report on legal and physical conditions of LGBTI people in Armenia.

Special Report on the State of the Rights of LGBT People in Bosnia and Herzegovina

On May 19th, the Joint Committee on Human Rights of the Parliamentary Assembly of Bosnia and Herzegovina (PSBiH) held a thematic session on the occasion of May 17th, the International Day Against Homophobia, Bi-phobia and Transphobia. This is the first time ever that a legislative body in Bosnia and Herzegovina discusses the state of the human rights of LGBT people, and thus it is a historic moment in the struggle of the LGBT movement in BiH.

The International Day Against Homophobia, Bi-phobia and Transphobia has been officially recognized in 2005 by the European Parliament and it is officially celebrated in more than 70 countries. On this day, May 17th, 1990, the World Health Organization removed homosexuality from the list of mental illnesses and from that day onwards, May 17th has been celebrated as a reminder of the importance of the respect for human rights of LGBT (lesbian, gay, bisexual and transgender) people worldwide.

Borislav Bojić, the chairman of the Joint Committee, opened the thematic session stressing the following: "The LGBT citizens remain completely invisible in the BiH society because of the fear of violence and discrimination". The situation in which LGBT people in BiH live was then presented, within the context of the human rights violations they face, by Mary Ann Hennessey, Council of Europe in Bosnia and Herzegovina, Saša Gavrić, a representative of Sarajevo Open Center, and Jasminka Džumhur, Human Rights Ombudsperson. During the thematic session, Saša Gavrić reminded everyone of the fact that LGBT people are 5-12% of citizen in any society, including BiH. "LGBT citizens face violence and discrimination, the large portion of which remains invisible to the BiH society, since the existing official mechanisms for reporting, processing and documenting of

discrimination and violence are not available to the majority of LGBT people, who, due to the fear of public reaction, and the reaction of the representatives of the institutions, report less than 10% of all the incidents." Hence, it was underlined that the protection of LGBT people and their rights is a duty of Bosnia and Herzegovina as a civilized state, and that it has to become a part of its culture and

social tradition.

The protection of human rights and the improvement of the position of LGBT people are incredibly important issues for the Western Balkan states on the road to full EU membership, as it was stated during the session. Accordingly, every year the European Commission pays considerable attention to the respect of the human rights and the minority rights, including the rights of the LGBT people, in the reports of the Council of the EU and the European Parliament on the progress of a particular country on the road to European integration. The representatives of the Parliamentary Assembly of BiH and of the Parliament of FBiH, as well as the civil society activists were actively engaged in the discussion following the presentation of the state of rights of LGBT people in BiH. After it was stated that there is a series of activities aiming at the improvement of the rights of LGBT people, it was concluded that the BiH Ministry for Human Rights and Refugees would begin the process of introducing the legislative amendments to the BiH Law on Prohibition of Discrimination in order to further improve their position in BiH society. Also, it was concluded that the Institution of Ombudsman for Human Rights in BiH should draw a special report on the protection of rights of LGBT people and deliver it to the competent bodies, including PSBiH.

Poland's parliamentarians dropped the debate on civil partnership proposal.

The Sejm lower parliamentary house has voted against a debate on a bill which would regulate civil partnerships – both heterosexual and homosexual – in Poland. The proposed law – which was put forward by the Democratic Left Alliance – foresees the possibility of joint payment of income tax, the right to inheritance as well as social security benfits in the event of one of the partner's deaths. However, the bill will likely now be shelved after MPs overwhelmingly voted against any discussion on the matter. Only 146 MPs voted for, while 215 were against, with 24 abstaining and 75 not voting

at all.

May 28th International Day of Action for Women's Health



On May 28, women's rights defenders and activists from all over the world mobilized to observe May 28th International Day of Action for Women's Health. Various activities from more than thirty countries have been reported by women's advocacy groups to be taking place to commemorate the Global Day of Action.

Collectively, activists called on the governments and the international community for the fullest inclusion of women's sexual and reproductive health and rights (SRHR) in the Post-2015 Development Agenda, and respect, protect, and fulfill women's right to health, dignity and bodily integrity.

May 28 Campaign was first established in 1987 by women's rights activists at the IV International Women's Health Meeting in Costa Rica, as a means to speak out on SRHR issues faced by women and girls all over the world..

This year's campaign highlighted the often forgotten link between SRHR and Institutional Violence, a form of violence against women perpetuated by the State, particularly experienced by women and girls if they are young, unmarried, poor, HIV affected, of diverse sexual orientations or gender identities, living with a disability, or in other vulnerable situations. The campaign focuses on 4 grave cases of Institutional violence: The denial of access to safe and legal abortion services; Forced and coerced sterilizations; Obstetric Violence and the denial of access to contraceptives and emergency contraception. All of these are issues commonly neglected and often normalized and endorsed by States.

Currently governments around the world are involved in the process of formulating the next development agenda in which they must address these human rights violations and uphold their existing commitments, by ensuring a comprehensive and rights-based approach to women's health, and accounting for the full spectrum of women and girls' sexual and reproductive health issues, needs, and rights.

Ireland becomes first country to vote in favor of marriage equality

Ireland has become the first country in the world to adopt marriage equality in a national election.

On Friday, May 22nd, 2015, voters approved a government-backed amendment to the Irish Constitution legalizing same-sex marriage. Ireland has become the 11th EU state to adopt equal marriage. In March 2015, the European Parliament emphasised in a resolution on human rights and

democracy in the world that it considers same-sex marriage or partnerships a "political, social and

human and civil rights issue."

WHO: Misoprostol for treating PPH included in the Model List of Essential Medicines

The World Health Organization has just released the Report of the 20th WHO Expert Committee on

the Selection and Use of Essential Medicines. The Report recommends that misoprostol be included in the Model List of Essential Medicines (EML) for the additional indication of treating post-partum

haemorrhage (in addition to preventing PPH) when oxytocin is not available or cannot be used safely. This means that health care providers who are not qualified to give oxytocin injections or where

oxytocin is not availble, e.g. in community-based facilities can now provide misoprostol to treat as

well as to prevent post-partum haemorrhage.

The Report states: "Two applications related to misoprostol were considered by the Expert

Committee. The Committee recommended listing misoprostol for the additional indication of postpartum hemorrage, when oxytocin is not available or cannot be used safely, but it did not

recommend deletion of misoprostol for the post-partum hemorrage prevention indication. The

Committee noted that no new clinical trial data to support deletion has been presented compared to

the same application in 2013."

The Committee also recommended the addition of three new contraceptive products to the EML: the

etonogestrel-releasing implant, the levonorgestrel-releasing intrauterine system and the

progesterone contraceptive vaginal ring.

200 Young Leaders selected for Women Deliver Young Leaders Program

Women Deliver has announced the selection of 200 young advocates, who will join the Young Leaders Program – a three year fellowship for young people under the age of 30, who are working for enhancement of health, rights and wellbeing of girls and women around the world. In June youth advocates will begin the e-course and they will attend Women Deliver Conference in Copenhagen in 2016. Among the selected Young Leaders are ASTRA Youth members from Poland and Romania, adding to 20 candidates from EECA region. The full list of chosen advocates is accessible here.

Romanian senators reject law proposal for a compulsory Sexuality Education curriculum in schools

Romanian senators voted against transforming the currently optional subject "Education for Health" ("Sexuality Education") into a compulsory graded course. The upper chamber of the Parliament supposedly rejected the law because of its incompatibility with the current law of Education. The Romanian law of Education states that curriculum changes can only be implemented by the Ministry of Education and these changes cannot be introduced and adopted directly by the Parliament. On the other hand, the representatives of the Ministry of Education are neither supportive of the idea of transforming sexuality education into a compulsory subject motivating that this change could overload the already crowded curriculum. Other voices accuse MPs of backing out because of fears of upsetting the Romanian Orthodox Church, still a powerful institution in today's Romanian politics. "Education for Health" is an optional subject implemented in some Romanian schools as early as 2004. The subject provides general information about hygiene and health tips starting from the first grade and detailed information about sexuality, STIs, hygiene and pregnancy prevention as early as the 7th grade. Sexuality education is partially covered by other compulsory subjects such as Biology or in some cases the Homeroom Class. In Romania curriculum changes are decided by the Ministry of Education. There is no previous record of Parliament getting involved in major curriculum changes. Even if some official sources claim that the national education law may be soon revised, there is no guarantee that in the following months Sexuality Education will be put back on the ministerial agenda.

Regional advocacy training and conference: Promoting Health and Rights, Reducing Inequalities

ASTRA Youth members from Georgia and Russia participated with other youth activists in the advocacy training for youth voices and priorities in EECA region that took place from 24th to 26th May in Sofia, Bulgaria. During the training they had a chance to improve their capacity in the advocacy skills related to Post-2015 Agenda and ICPD. Also, participants of the training prepared advocacy messages with youth priorities: education and meaningful youth participation, which were presented to the parliamentarians during *Promoting Health and Rights, Reducing Inequalities Towards Better Sexual and Reproductive Health Outcomes* conference that was held by UNFPA EECARO from 27th to 29th May. During the conference ASTRA Youth members participated in the working groups focused on Sexual and Reproductive Health of key populations at higher risk of HIV and Sexual and Reproductive Health in the Youth Age. Georgian representative highlighted the issues that young people are facing in rural areas, especially such problem as access to education and SRH youth friendly services. Russian advocate was calling for the importance of providing more visibility for transgender youth population by implementing the practices of empowerment and investing in the research on this topic.

Youth advocates were fighting hard to include youth priorities and identify the main problems of youth from EECA region at the conference. We hope that parliamentarians will hear voices of young people from the different regions and include them in SRHR priorities in their countries. The conference concluded with an adoption of **Sofia Declaration of Commitment**, calling on governments to prioritize young people's sexual and reproductive health and reproductive rights. Young Leaders conference in Moldova

More than 50 young parliamentarians, representatives of governments, private sector, journalists and civil society activists attended the 'Young Leaders for Population and Development' conference, which took place on 11-12 May in Chisinau, Moldova. The conference aimed to gather young leaders from diverse sectors to discuss the progress made since the 1994 ICPD Programme of Action (PoA) and identify the remaining gaps that need to be addressed. The two-day debates focused on population issues: migration, population ageing, fertility, sexual and reproductive health and reproductive rights and gender equality.

First day of the conference was concentrated on assessment of progress in population dynamics in the last 20 years. Participants were discussing in working groups innovative solutions for burning issues in the area of population dynamics, SRHR, gender equality and meaningful youth participation. The regional focus was also raised at the overview of ICPD for Eastern Europe and Central Asia and debates on controversies around issues of population and development. Conference participants had also the opportunity to visit institutions working on population and development in Moldova: youth friendly clinic Neovita, HIV/SRH centre 'Positive Initiative' and Gender Equality centre. On the second day the sociological review of population dynamics was presented, paying attention to reasons for

low fertility rates. Following panel discussions regarded the contribution of media, private sector and

young leaders to the advancement of the ICPD programme.

ASTRA Youth members from Poland and Azerbaijan were present at the conference, sharing

experiences on youth SRHR in the region, contributing to working groups' and general discussions

and raising the importance of meaningful youth participation in policy-making processes.

State of the world's mothers report 2015

One of the worst places in the world to be a mother is in an urban slum. The 16th Annual State of the World's Mothers Report delves into a comparison of the health disparities between wealth and poor women and children living in cities around the world. In 2015 more than half of the world's population lives in cities. Unfortunately, a growing proportion of child deaths are occurring within these cities in urban slums.

This publication is a result of a successful cooperation between the Foundation for European Progressive Studies (FEPS) and the regional gender programme of the Friedrich-Ebert-Stiftung (FES) on critically analyzing anti-gender discourses in European far right and conservative party programmes and the role of the respective parties in shaping the discourse and mobilisations. The publication looks at five case studies: Hungary, Poland, Slovakia, France and Germany with the purpose to comparatively examine the commonalities and divergences of this phenomenon, also offering a chronological overview.
