BURNING ISSUE

New report from Council of Europe Commissioner for Human Rights calls for progress to ensure women's sexual and reproductive health and rights in Europe

"Women's sexual and reproductive health and rights are human rights. Regrettably, however, women in Europe still have these rights denied or restricted as a result of laws, policies and practices that ultimately reflect continuing gender stereotypes and inequalities. States must acknowledge and address these violations and resolutely commit to advancing gender equality in this crucial sphere of life", said the Council of Europe Commissioner for Human Rights, Nils Muižnieks, while releasing a report on this topic in early December.

The document provides an overview of states' obligations under international and European human rights standards in the field of women's sexual and reproductive health and rights. It provides examples of shortcomings that European states must address in particular as regards the rights to life, health, privacy, non-discrimination as well as the right to be free from torture and ill-treatment,

with a particular focus on comprehensive sexuality education, modern contraception, safe and legal abortion care, and quality maternal health care.

The Commissioner sets forth 54 recommendations aimed at helping European states address the pressing need to:

- renew political commitment to women's rights and guard against retrogressive measures that undermine women's sexual and reproductive health and rights;
- establish health systems that uphold and advance women's sexual and reproductive health and rights;
- ensure the provision of comprehensive sexuality education;
- guarantee the affordability, availability and accessibility of modern contraception;
- ensure all women's access to safe and legal abortion care;
- ensure that refusals of care by health care workers on grounds of conscience or religion do not endanger women's timely access to sexual and reproductive health care;
- respect and protect women's human rights in childbirth and guarantee all women's access to quality maternal health care;
- eliminate coercive practices and safeguard women's informed consent and decision-making in sexual and reproductive health care contexts;
- ensure all women's access to effective remedies for violations of their sexual and reproductive rights;
- eliminate discrimination in laws, policies and practices and guarantee equality for all women in the enjoyment of sexual and reproductive health and rights.

"Sexual and reproductive rights protect some of the most significant and intimate aspects of our lives. Ensuring these rights for women is a vital component of efforts to achieve women's rights and gender equality. Given the resurgent trends seeking to roll back protections in this field, we must ensure that we remain committed to these rights, which were established only after a long struggle. States have the duty to provide all women with accessible, affordable, good quality sexual and reproductive health care and services", said Commissioner Muižnieks.

SDGs for Young People, Young People for SDGs in Sofia

The three-day meeting held in Sofia, Bulgaria entitled SDGs for Young People, Young People for SDGs. Tracking Progress for Young People. Europe and Central Asia Regional Dialogue on ICPD and SDGs gathered representatives of youth-led organizations and UN agencies, policy makers, statisticians, and regional partners from various countries of Europe and Central Asia. The main purpose of the event was to create a framework for youth advocacy and develop a regional monitoring system to track progress on youth-related goals and targets included in the Sustainable Development Goals of the 2030 Agenda and the Programme of Action adopted at the International Conference on Population and Development.

On the first day of the meeting participants worked in groups on identifying needs and challenges of young people of the Europe and Central Asia region in the following thematic areas: health, employment, civic engagement, education, and gender.

The next day's sessions focused on the use and abuse of statistics, as well as selecting and validating the needs and challenges in each of the five thematic areas against the ICPD and SDGs targets and indicators. The working groups tried to select specific SDG and ICPD indicators against the previously identified needs and challenges. The day ended with a panel on initiatives on national and local levels

that adavance the youth agenda. Five presentations from experts, as well as state and local

government representatives were followed by a plenary discussion.

On the third day participants debated policy-making and implementation at both national and local

levels, first in regard to the possible ways of using available data to hold governments accountable for their actions or lack thereof, and then the necessary resources needed in order to be more

effective and persuasive in doing so.

During the concluding session of the meeting through an anonymous voting process participants chose Uliana Avtonomova from Ukraine to be their representative as a member of the United

Nations Economic Commission for Europe experts group on regional monitoring framework on ICPD.

The event took place on December 4-6, 2017 in Sofia, Bulgaria and was organized by Y-PEER

PETRI Sofia and UNFPA Eastern Europe and Central Asia Regional Office. ASTRA Youth was

represented by the network coordinator.

The Sexual Rights Initiative invites you to visit our new and improved Universal Periodic Review Sexual Rights Database. The database allows you to search all the sexual rights related recommendations and references made during UPR sessions at the UN Human Rights Council, including progress on the implementation of accepted recommendations. The database is part of a suite of tools developed by the SRI to support State accountability for the realization of all human rights related to sexuality, reproduction and gender. UPRDATABASE.ORG

Features: Open access — password no longer required; New design; User friendly search options; Includes all sexual rights recommendations from UPRs 1-26 with UPR 27 data currently in the process of being uploaded; Includes sexual rights references in UN Compilation Reports, Stakeholder Summaries, National Reports; Includes progress on recommendation implementation as reported by the State under Review; Rolling updates following UPR report adoptions; Broad range of sexual rights issues including abortion, birth registration, sexuality education, discrimination on the basis of sexual orientation, discrimination on the basis of gender identity, sex work, HIV, early marriage, forced marriage and many more.

The Universal Periodic Review of the United Nations Human Rights Council is a process to review each of the 193 Member States of the UN on its entire human rights record every four and a half years. It is a powerful tool to hold governments accountable for sexual rights violations and to advocate for changes to particular laws and policies that impact on human rights related to sexuality, gender and reproduction. The SRI has been actively involved in the UPR process since its establishment in 2006 and has collaborated with over 150 national and regional organizations, activists and academics in more than 100 countries to consistently raise sexual rights at every UPR session. We are committed to ensuring sexual rights are systematically integrated into the UPR process as a critical means of ensuring accountability for human rights obligations related to gender, sexuality and reproduction.

The 62nd Session of Commission on the Status of Women

The 62nd Session of Commission on the Status of Women (CSW 62) will be held from 12 to 23 March 2018 at the UN headquarters in New York. This year's priority theme is "Challenges and opportunities in achieving gender equality and the empowerment of rural women and girls" and the review theme is "Participation in and access of women to the media, and information and communications technologies and their impact on and use as an instrument for the advancement and empowerment of women". Women's Room - Center for Sexual Rights

The Women's Room - Center for Sexual Rights (ženska soba - centar za seksualna prava) from Zagreb, Croatia is a non-governmental, feminist, non-profit organization established with the aim of empowerment of women and raising awareness of institutions and general public about women's sexuality and sexual rights through education, research, advocacy and public work. The Women's Room provides direct and indirect assistance and support to all sexual violence survivors. Women's Room envision a society free from patriarchy, discrimination, misogyny and gender-based violence, where individual choice is the fundamental value.

Goals of Women's Room are:

- Elimination of all forms of sex, gender and sexual discrimination;
- Empowerment of women in exercising their fundamental human rights;
- Prevention of sexual violence against women and sexual and gender minorities;
- Provision of direct help to women who have survived sexual violence;
- Promotion and protection of sexual rights pursuant to the Declaration of Sexual Rights;
- Introduction of comprehensive and inclusive sexuality education based on scientific facts, at all education levels;
- Promotion of positive attitudes to female sexuality, sexual health and freedom of choice;
- Elimination of discrimination based on gender expression and/or identity, sexual orientation, and intersexual characteristics;
- Empowerment of LGBTIQ persons in exercising their fundamental human rights.

Organizational goals are fulfilled through 5 areas of work: Center for Victims of Sexual Violence, Education, and Scholarly research, Publishing, Development of public policy against sexual violence through public works, advocacy and networking.

Our core activity is Center for Victims of Sexual Violence in which experts provide direct and indirect support and help for victims of sexual violence. The team works with victims through providing support during the process of reporting sexual violence (accompanying the survivor to the police and hospital); preparations for court proceedings; counselling and therapy: crisis counselling (medical, legal and psychological), trauma-focused therapy, psychological counselling for family or friends of the survivor; development of and publishing different materials.

Education is another main activity. Women's Room team makes great effort in the implementation of educational programs on the topic of violence against women, sexual violence, trafficking in women for sexual exploitation, sex and gender, sexual rights, women's sexuality, sexual and gender minorities. Educational programs are implemented through trainings, workshops, lectures, supervision, consultations, seminars, performances, concerts and other public events.

All activities are focused on female survivors of gender-based violence with emphasis on sexual violence, children, youth, representatives of relevant state institutions, representatives of civil society organizations, LGBTIQ population persons.

Women's Room launched a web site "Safe Zone" (www.sigurnomjesto.hr/en/) intended for women who are victims of all forms of violence in 2012. This web site have unique search engine with contacts of all relevant institutions (police stations, hospitals, courts, civil society shelters and counselling centers, etc.) for all Croatian regions.

"Women's Room is an organization that has been intensively involved in the issue of preserving the right to choice, the right to abortion that is intensively violated in Croatia. Being a member of ASTRA network is useful because it allows us to become acquainted with policies in other countries, practices and actions of other civil society organizations. Gathering information and learning from other members is important to us so we can contribute to the struggle to preserve reproductive rights in Croatia."
